AVAILABILITY: Reservations may be made up to one year in advance of desired date. Inquiries for availability of date may be made by calling Aquatics at 757-788-3301.

The indoor pool is available for rent on Saturdays from 5pm – 8pm and on Sundays from 11:00pm-7:00pm. Reservations will not be accepted for holiday weekends.

We do not guarantee a private lobby area. If youth services are open during your scheduled party then it is understood that there may be other customers in the lobby area passing through however they will not be allowed to interfere with your function.

COST: Package 1: \$60.00 – includes reservation of the pool for 1 full hour of swim time, includes lifeguard.

Package 2: \$75.00 – includes reservation of the pool facility for 1 full hour of swim time, use of the lobby area for food and drinks (supplied by patron), lifeguard and available pool toys for up to 15 swimmers.

*15 – 30 swimmers will require an additional lifeguard at a rate of \$15.00 per hour of the party.

*Additional swimming time may be purchased at the rate of \$30.00 per hour

REGULATIONS/CONDITIONS:

- Staples, nails, tape or glue may be used for decorating purposes but must be removed completely and the area in the condition it was in prior to your arrival.
- A 20% **non-refundable** deposit is due at time of reservation. The balance is due fourteen (14) days prior to the event. Failure to pay balances in a timely manner may result in the cancellation of the reservation.
- No animals are permitted in the facility.
- The facility will be opened 15 minutes before the start of the event.
- All swimming must be done first. After the swimmers have changed then they can proceed to the lobby.

CANCELLATIONS/REFUNDS: Cancellations will be accepted up to seventy two (72) hours prior to the start of the reservation. Refunds will not be given after the event has started and inclement weather arises. All deposits are **non-refundable**. All refunds are issued through NAF Financial Services directly to the customer.

GENERAL: The indoor pool is located at 100 Stilwell Rd, next door to the bowling alley. All activities (decorating, eating, presents, etc) must be accomplished within the reserved time frame. **If military requirements conflict with your scheduled event, even after approval, your scheduled date may have to be withdrawn or rescheduled.**
